SECTION 2: HAZARD IDENTIFICATION

EMERGENCY OVERVIEW

CAUTION: This product is a clear to pale yellow or clear blue liquid with a pleasant odor. Direct contact with eyes may cause irritation, with possibility of corneal injury if not removed promptly. It may be harmful if swallowed. Repeated or prolonged excessive exposure with skin can result in defatting and drying which may result in irritation and dermatitis. Keep out of reach of children. No significant environmental effects. Not a fire hazard. Product is stable.

This product is labeled in accordance with regulations administered by the Consumer Product Safety Commission. The use pattern and exposure in the workplace are generally not consistent with those experienced by consumers. POTENTIAL HEALTH EFFECTS

SECTION 4: FIRST AID MEASURES

EYES: Immediately rinse eyes with plenty of water for at least 15 minutes, occasionally lifting upper and lower lids, until no evidence of product remains. Get medical attention if pain or irritation persists.

SKIN: Rinse affected area with large amounts of water until no evidence of product remains. Get medical attention if irritation persists.

INGESTION: Treat symptomatically and supportively. Maintain airway and respiration. If vomiting occurs, keep head below hips to prevent aspiration. METHODS FOR CONTAINMENT AND CLEAN UP
